Unfinished Business:

Project Updates (N. Mehmed) via Jeff in Nathan's absence.

Car Wash – Trash is accumulating, building is unsecure. Jeff hasn't been able to get in touch with them. Nathan is concerned because they are having issues with other communities. Sometimes they don't build what is presented. Specifically lighting/sound. Need to keep an eye on the drainage area so they don't disrupt anything. Concern is around hours of operation as well. Jeff will attempt to call/email again before the building has to be secured because it's being a safety issue. They will be billed if we can't get in touch with them.

Ordinance stands that you can't be a nuisance.

ZBA coming up. Planning Commission will continue to get updates from Nathan.

Fox – Slow start. Everything going well. Nathan is happy with the revisions.

Legacy – They are moving along. Neighbor complaint – started work at 5:30 am with loud trucks with lights. Concrete work has stopped due to weather. Framing is being set on the villas. Concrete work is ready when the weather is. They have been stewards up to the 5:30 am work.

Kinsey – Closed today. Sewer connection is happening. Trench needs to be covered for safety reason. Someone went through barricades and almost hit someone. More money came through for project. Kinsey to Main will be developed.

Village Station – 5th or 6th Condo sold. Moving forward and making progress. Mowing issue has been corrected. Neighbors don't mow because there is a steep hill.

Hanover – Talks were for a 2nd phase but they haven't come to Village for another phase. Retention ponds are still holding water. Special

permission to go under 100th, but water around there. Fences have gone away so we need to keep water issues safe.

Caledonia Optical – ZBA Appeal for signage ordinance is scheduled May 13th hearing.

404 East Main – ZBA Appeal - wants to split the current lot. Wants to turn the barn into a living unit, May 13th @ 7 pm. IMS has denied application. He wants a 50 ft lot and a setback variance. 700 on main level, and he doesn't have it.

Gooseneck Trailer – Street is not the Village's ordinance. Reported to Sheriff.

May 13th ZBA meetings are being advertised. ZBA is the Village Council. Is it ordinance issue or unique issue? Need permission to go onto a property – Need to be added to application. PC can't talk with applications.
